Social Security pays benefits to people who cannot work because they have a medical condition that has lasted or is expected to last at least one year or result in death.

OCS can assist in simplifying the application process. We will:

- Educate the client regarding benefits
- Obtain proper authorizations, gather medical documents, complete the application for Social Security Disability and/or Social Security Income
- Forward application materials to Social Security for review
- Conduct follow up with the Social Security Administration until benefit eligibility has been determined

SSDI

To qualify for SSDI, you must first have worked in jobs covered by Social Security and have earned sufficient credits based on taxable work to be "insured" for Social Security purposes. Then you must have a medical condition that meets Social Security's definition of disability. The Social Security administration considers you disabled if:

- You cannot perform the work that you did before
- They decide that you cannot adjust to other work because of your medical condition(s)
- Your disability has lasted or is expected to last for at least one year or to result in death

SSI

SSI benefits are based on financial need. This program is financed through general revenues from taxes, meaning benefits are not based on your prior work history.

- In most states, beneficiaries will automatically be eligible for Medicaid
- SSI disability benefits are payable to:
 - individuals age 65 or older
 - adults who are disabled or blind
 - children who are disabled or blind
- Eligibility requirements:
 - have limited income and resources
 - meet the living arrangement requirements
 - is a U.S. citizen or national, or in one of certain categories of aliens
- The monthly payment varies up to the maximum federal benefit rate, which may be supplemented by the state.
